### President's Report for 2009

This report is submitted on the occasion of our annual elections and meeting of membership, as required by our council bylaws. We have had a busy and productive year. The following summarizes our key programs:

**Organization** - We established a Communications Committee, bringing together the Public Affairs, Newsletter, Web Site, and other related committees to ensure that our message is consistent and supports the Navy League Mission. We also established a Strategic Planning Committee to continue to look at where our counsel is going and to ensure that our programs our supporting the Navy League Mission. Both committees have become very active since early summer.

## Comings and Goings

The Naval Undersea Museum Auditorium at Keyport was the setting for the Commander, Naval Undersea Warfare Center headquarters change of command Nov. 4. It marked the first time the ceremony has been held at Keyport.

Rear Adm. David C. Johnson was relieved by Rear Adm. Thomas G. Wears who becomes the 12th Naval Undersea Warfare Center commander.

Wears was previously in the Northwest starting in February of 2001 when he assumed command of USS Alabama (SSBN 731). This was followed by a tour as Deputy Commander of Submarine Squadron 17 and 19 where he worked with Naval Special Warfare, developing and implementing submarine operating concepts.

Johnson, will continue in the position he also held as deputy commander for undersea technology, and deputy PEO Submarines for the Ohio-class submarine replacement program.

# CNO Releases 2010 Guidance



WASHINGTON (NNS) -- Chief of Naval Operations (CNO) Adm. Gary Roughead released his Guidance for 2010 Sept. 2.

CNO said the guidance reaffirms the vision, mission and principles as in the previous guidance, and that his focus areas of building a future force, maintaining our war fighting readiness and developing and supporting our Sailors, Navy civilians and their families remain unchanged.

The guidance continues to carry out the 18 intentions from the 2009 Guidance, but also identifies five intentions that CNO will place particular emphasis on in the coming year: continue to be the dominant force, ready naval forces across all maritime missions, build a Navy with appropriate force structure and strategic lay down, achieve decision superiority, align the requirements, resources and acquisition processes; and evolve and establish international relationships.

CNO said this guidance will provide new opportunities that will ensure our continued maritime dominance globally.

# Navy Using Alternative Fuels

Navy Region Northwest (CNRNW) and Naval Facilities Engineering Command (NAVFAC) Northwest opened two new environmentally friendly fuel tanks at Naval Base Kitsap (NBK) Bangor, this year. One fuel tank holds Ethanol (E85) and the second tank holds Bio-diesel (B20). They are available for use in government vehicles.

"Today we are switching our vehicles to a corn-based E85 type of fuel," said Capt. Mark Olson, NBK commanding officer. "From the swap out of the 136 E85 vehicles here, we can expect an immediate air quality improvement of 7.6% from gasoline vehicles at Bangor."

"Along with the 136 E85 vehicles, there are about 27 vehicles at NBK Bangor which will use the B20 fuel, with numbers of both vehicles expected to rise in the upcoming future. Our impact on the environment is going to get significantly less as soon as we start using the bio-diesel fuels," said Rear Adm. James Symonds, Commander, Navy Region Northwest. It is cheaper, cleaner, and reduces our dependency on foreign oil.

NBK is the first Navy station in the Northwest to introduce the new environmentally friendly fuel. However, it is not the last. The Navy

Exchange will open its new E85 pump at Naval Station Everett Harborside fuel station in May, soon to follow this trend is Naval Air Station Whidbey Island, and NBK Bremerton.

"We are currently leading the region by getting the infrastructure in place to start using alternative fuels," said NAVFAC NW Commanding Officer Capt. Robert Schlesinger, "and reduce our dependence on oil by using these vehicles that allow us to not burn petroleum products."

"I think that with enough publicity for this fuel station it will have a positive impact on the outside community," said Randy Randklev, EJB Transportation Fleet Support. "This is a great thing not only for the military but for the environment overall." The NBK Bangor alternative fuel facility is open to government vehicles only.

## Don Green Witnesses the Attack on Pearl Harbor

Our Dec 12 program speaker will be our own member, Don Green. Don was a Navy Veteran of the Japanese attack on Pearl Harbor on Dec 7th, 1941.



At the time, Don was on the USS Pyro, an ammunition ship tied up in the ammunition depot referred to as West Loch on the north eastern edge of Pearl Harbor itself. The Pyro was loaded with bomb type ammunition as was the pier and a barge that was alongside. Don, therefore, had much to be concerned when an enemy bomber made a close approach and released a "near miss" bomb. Don remembers the face of the haughty pilot as he sped by at close range. Don also witnessed the carnage and damage absorbed by the Pacific Fleet. This will be a program of great interest and historical value to all our members.


