# Captain's Corner - "Individual Augmentees"

Hello Navy League! I hope you're off to a great start for 2008! As I contemplated what topic might be appropriate for this month's Captain's Corner there was one example of

service shared by our Sailors that percolated right to the top, and that issue is the challenges faced by our "Individual Augmentees", also referred to as IA's. These are Sailors who are assigned tours ranging from six months to over a year in support of the Army, Marine Corp or Joint Headquarter's elements outside of the Navy infrastructure. Many of the jobs are assigned to support missions where the armed services are over tasked based on our current manning, or where the rotation rate for active duty, reserve or national guard forces have stretched our fellow services to the limit. Since teamwork is always our goal, the Navy will always support our fellow services as they encounter these challenges. We currently have over 12,000 Sailors Navy wide assigned to IA positions. The majority of those (8,000) are in Iraq, Afghanistan and Djibouti, Africa. The jobs assigned range from logistics support (ordering or processing spare parts, food, water, fuel, etc.), to security assistance (guards at entry control points), to support for communications infrastructure (computer based and voice communications). The variety of assignments is really quite broad, but that's an area where the Navy excels - flexible response to any challenge encountered. Perhaps the most challenging part of an IA assignment is not the length of time or the serious nature of the mission, but the fact that it's assigned in a location

outside of the Navy's support infrastructure. Our Sailors are used to the Navy systems for meals, sleeping accommodations, the ways to train, manage pay issues and conduct themselves in a day to day lifestyle. When our Sailors are brought into a different lifestyle and support base, it is challenging for them to acclimate to the new conditions. Where our Chiefs and Officers would normally be there to support them getting started in a new unit, for the IA's there are not necessarily Navy Chiefs or Officers to help them get their feet on the ground. Kind of like visiting a foreign country where English is not widely spoken and encountering a life threatening situation whether it be due to medical emergencies, crime or natural disaster all by yourself. Tough challenges for our young Sailors and a situation where our Navy units focus a lot of effort to assist, even though we are thousands of miles away. The Navy has put together a proactive program to help our Sailors prepare for their IA assignments to get them the appropriate training, to ensure their home unit maintains contact with them while they are forward deployed, and to provide them with post deployment assistance as they decompress from the challenging times they have faced at the tip of the spear.

As you consider the many contributions our military service members make during these times in support of the global war on terror, please consider the incredibly valuable service provided by our Individual Augmentees. These are tough assignments and our American Service Men and Women deserve that pat on the back. Thank you Navy League for your patriotism and devotion to country.

## KITSAP'S FALLEN HERO MEMORIAL NEEDS DONATIONS

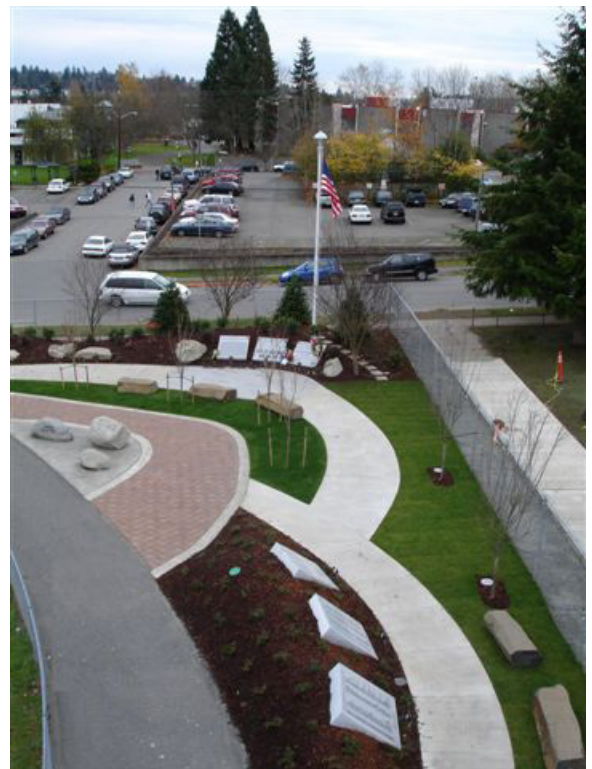
The "Path of Freedom," Kitsap County's memorial to our fallen heroes, can be seen night or day at Bremerton High School's Memorial Stadium. Entrance to the park is through the walkway gate next to the covered stands.

438 men & women of Kitsap County have been killed in action since WWI. The Semancik Foundation, with the cooperation of the Bremerton Schools, and with much of the labor and materials from Sean Olmsted's Clear Creek Nursery, expanded on the stadium building project of the 1946-47 Bremerton Student Body. Three 2,000 lb. granites list our Kitsap fallen heroes in the park with the seven military insignias as the centerpiece and the quote, **"For those who have given life, limb and soul, so we might enjoy our freedom."**

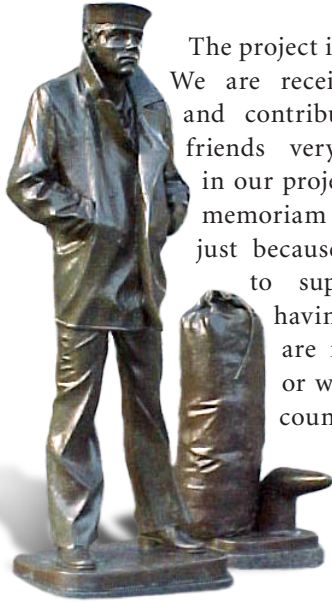

BVA member, P.J. Scott of the Washington Regional Group, currently hosts and produces a half-hour monthly program entitled "Veterans Forum" for KBAT television. The program can now be seen and/or listened to via the Internet. In February, "Veterans Forum" will feature The Lone Sailor Project. It will air five times: Tuesday, Feb. 5th at 9:30am; Thursday, Feb. 7th at 6:00pm; Friday, Feb. 8th at 2:00pm; Wednesday, Feb. 13 at 4:30pm; and Saturday, Feb. 16th at 6:30pm.

"This program has never finished lower than third among the most viewed local programs," said PJ, who credits the large audience to the three Navy bases and a larger-than-average veteran population in the Seattle-Tacoma area.

# Rear Admiral Symonds makes January Luncheon Informative and Interesting



Rear Adm. James Symonds, commander of Navy Region Northwest, was the guest speaker at the Bremerton-Olympic Peninsula Navy League's monthly luncheon on Jan. 8. Symonds took command of Navy Region Northwest on July 11. He previously directed the Navy's Environmental Readiness Division. He amassed 4,000 flight hours in an A-6 Intruder and more than 1,000 carrier landings. He was stationed for 14 years at Naval



Station Whidbey Island. Adm. Symonds brought to our attention that there are over 50,000 civilian employees, contractors and Navy personnel in the Northwest, and that over 90% of the world's trade moves over the seas and Tacoma and Seattle's ports are the closest to the Asian nations. Also, 70% of the planet is covered by water. All are a concern for Unified Security of our maritime forces, the Coast Guard, the Marines and the United States Navy.

An additional highlight of the luncheon was Alice and Dave Thomas being presented an award for their "Outstanding Service" to the Brem-Olympic Council of Navy League.
