

Navy League Salutes SKOOKUM Contract Services



SKOOKUM CONTRACT SERVICES

Skookum Contract Services, a division of Skookum Educational Programs, a Washington Based nonprofit corporation accomplishes their mission of creating employment opportunities for people with disabilities by performing services for government entities.

Skookum began in the early 1980's when founder and current CEO, Jim Westall, wanted to expand the horizons of students with developmental disabilities at Port Townsend High School. In 1992, Skookum received national acclaim after their small jump rope company which was started out of a rented garage in 1988 was profiled on NBC's Today Show and their jump rope was chosen one of the "100 Best Products" at the prestigious

New York Toy Fair. The jump rope company still operates in Port Townsend.

Skookum began working with the Military 10 years ago performing grounds maintenance at Naval Magazine Indian Island employing people with severe disabilities. Their contracts now include, Naval Base Kitsap Bangor, Fort Worden, and most recently, as the Prime Contractor for Janitorial, Hospital Housekeeping and Grounds Maintenance Services throughout the Navy Region Northwest. They also provide services to Fort Lewis operating the Central Issue Facility and providing wheeled vehicle maintenance for the Stryker Brigades. In 2006, they were awarded a contract to maintain the GSA vehicle fleet at Fort Riley, KS, leaving the Northwest for the first time.

Today Skookum provides employment for over 500 people with severe disabilities. More information about Skookum Contract Services can be found at www.Skookum.org.
