## Rear Admiral Joseph P. Aucoin, Commander Carrier Strike Group 3

The guest speaker for our March luncheon will be Rear Admiral Joseph P. Aucoin. He graduated from North Carolina State University with a Bachelor of Science in Electrical Engineering. He received his commission through their NROTC program in 1980. He was designated a naval flight officer in 1981 and reported to Fighter Squadron (VF) 1010 for initial training in the F-14 Tomcat.

Aucoin served on the following aircraft carriers: USS America (CV 66), USS Nimitz (CV 68), USS Theodore Roosevelt (CVN 71), and USS Kennedy (CV 67). He commanded Carrier Air Wing 5 forward deployed in Japan and embarked aboard the USS Kitty Hawk (CV 63).

Ashore, he has served in the Program Planning and Development Branch

(N801), OPNAV Staff; Programming and Budget Division (PBAD), J8, Joint Staff; Aviation Strike Warfare Requirements (N880); head, Program Planning and Development Branch (N801); head, Maritime, Unmanned Aircraft Systems, Aviation Training Plans and Programs (N882) and deputy director, Air Warfare (N88B).

Rear Admiral Aucoin has accumulated more

than 4700 hours and more than 1300 carrier arrested landings. His personal awards include the Silver Star, the Legion of Merit, the Distinguished Flying Cross with V and Bronze Stars. He is an Arthur S. Moreau Scholar and holds masters degrees in Public Administration from Harvard University and in National Security Studies and Strategic Affairs from the Naval War College.

## Retired Captain Will Lent, U.S. Navy

Each month, we are highlighting a member of our Board of Directors. This month, we are highlighting retired Navy Captain Will Lent. Most of you know Will Lent as our very capable Program Chairman. He obtains the guest speakers for our luncheons and our various banquets. He always does a great job of introducing these guest speakers to provide us with a little introduction to the speech we are about to hear.

Will is a real "history buff", and has been since he was a child. When he serves as our Navy League's luncheon speaker, by providing some of his WWII history lessons, we have some of our biggest crowds in attendance. He has an incredible way of presenting historical facts and behind the scenes events. In addition to providing these lectures on U.S. history to our Navy League group, Will has been part of various lecture series at Olympic College, the Kitsap Historical Museum and the Naval Undersea Museum.

Will Lent graduated from the U.S. Naval Academy in 1953 with a Bachelor of Science degree in Marine Engineering. He furthered his education by obtaining his Master's degree in Engineering from the U.S. Naval Post Graduate School in Monterey, CA. Will served on five submarines during his Naval career, including tours as Executive Officer and Commanding Officer.

After retiring from the Navy as a Captain (O-6), Will started his civilian career as the Polaris Submarine Project Officer at Electric Boat Division-Groton, CT. He served as the Ballistic Missile Submarine Project Officer for NAVSEA (The Bureau of Ships) in Washington, D.C. And, then, he got smart and moved out to our lovely Pacific Northwest when he became the Head of the Planning Department at

the Puget Sound Naval Shipyard. Will then moved on to serve as the Executive Director of the United Way of Kitsap County for five years.



Will then went back into his engineering career when he became the Defense Department Contractor for Unified Industries, Inc. He finished off his long career with serving as the Field Office Manager for Unified Industries.

Somehow, with this very busy work schedule, he found time to serve as the President of the Bremerton Rotary Club, the President of our Bremerton-Olympic Peninsula Navy League Council and the Chairman of the Bremerton City Civil Service Commission. Will Lent was the recipient of the Washington State 1991 "Evergreen Award". This is an award presented to an individual who is being recognized for their volunteer and community service activities.

And a biography of Will Lent can't be complete without mentioning his involvement with the Naval Undersea Museum. He was very instrumental in the founding of and the obtaining grant money to build the Naval Undersea Museum in Keyport. He has been credited for signing up 15,000 of the first 16,000 members of the museum's foundation. Will obtained the initial half-million dollar grant from the state of Washington. He worked with Congressman Norm Dicks to obtain a \$3.5-million-dollar federal grant. Over the years, Will has been credited for obtaining \$6.7 million out of some \$10.7 million dollars of grant money. And..., his lovely wife Nora worked in the gift shop at the Naval Undersea Museum for a number of years.

We are lucky to have Will Lent serving on our Navy League's Board of Directors!

## Safe and Secure for over 100 Years



*This is the very first Kitsap Bank in the county. It was located on the corner of Bay Street and Sydney in Port Orchard. The building is still standing and many will recognize it.*

Kitsap Bank, headquartered in Port Orchard, WA, is a century-old bank founded in 1908 by Jacob Furth, a Seattle Financier; and three Port Orchard men, George E. Miller, Peter Nordby, and Superior Court Judge John B. Yakey. In 1922, a legacy of family ownership began when Frank E. Langer purchased controlling interest in the Bank. He later served as President until his death in 1952, at which time his wife, Hannah Langer, took over, becoming the first female bank president west of the Mississippi River. Still today the family is actively involved in the bank with Helen Langer Smith, Hannah and Frank's daughter, serving as Chairman of the Board, and Cydly Langer Smith, their granddaughter, as Vice Chairman.

From these humble beginnings, Kitsap Bank has grown to be a leader among community banks in the nation with 25 offices in the Greater Puget Sound region. Today, assets are nearly \$1 billion strong, and they employ over 250 people.

Kitsap Bank is one of our new Community Affiliates. We are delighted to have them as partners in our support of the sea services.
