Northwest Navy Notes: January 2009

"The Pirate and the Fisherman"

Imagine a fisherman from a village in the developing world. He may live in Africa, Southeast Asia, or South America. He supports himself and his family as his people have done for hundreds of years. But recently his catches have been smaller: His country's naval forces



and coast guards are too small and underfunded to stop the illegal drift net operations that deplete local fish stocks. He's bringing in less money and can no longer afford to send his children to school. The village water well is old and poorly maintained, and his wife is ill from drinking contaminated water. There is little medical care available, and doesn't make enough money to pay for even that. The information he receives about the outside world comes from radical militiamen that come through his village and spread messages of hate about America. The prospects for he and his neighbors look grim... they don't have much left to support themselves, except for their boats and their guns.

Now imagine that same fisherman, from that same village. But now, his catch is improving. U.S. Navy ships are helping his country enforce fisheries laws, and illegal drift netters are staying away. His family is healthy...a Navy SEABEE Battalion spent a few weeks in his village, repairing the well and renovating the school house. Their drinking water is clean, and his children are in school learning in a more modern environment. A Navy medical team spent three days giving

free vaccinations and dental care to everyone. Now diseases that killed or weakened scores of the fisherman's fellow villagers are now eradicated. He's able to support his family, his children have a bright future, and for their prosperity and hope they credit the United States

of America.

The most effective way to fight piracy and activities like drug trafficking and terrorism, is to create conditions where those activities aren't the only viable ways to make a living. Poverty, disease, failing governments, lack of education, lack of hope-- those conditions breed piracy. In today's globalized world, the actions of a few criminals from a village in East Africa can cause problems right here in Western Washington.

"A Cooperative Strategy for 21st Century Seapower," the Maritime Strategy, elevates humanitarian assistance to a core Navy mission. Through actions like ABRAHAM LINCOLN'S tsunami relief work and the PACIFIC PARTNERSHIP operation involving USNS MERCY, we've found that humanitarian operations require relatively little cost, but produce great rewards. Navy ships and assistance teams spending just a few days in an impoverished yet strategically important area can change thousands of lives for the better, and reap huge benefits for decades to come. Sea power today is working for a more secure and prosperous tomorrow, and helping make the difference between pirates and fishermen.

Ivy Green Cemetery is Veteran's Final Resting Place

Naval Hospital Bremerton's chief petty officer (CPO) selectees showed respect for those who made the ultimate sacrifice for their country by helping to renovate the hallowed ground of Ivy Green Cemetery of Bremerton.

There are approximately 6,000 people laid to rest at the cemetery, of which several thousand are military veterans. Ivy Green is also the resting site for Navy Quartermaster John H. Nibbe, who was one of the earliest recipients of the Medal of Honor, was cited for his courage under fire while on the gun boat USS Peterel during Civil War action on the Yazoo River in 1864.

"It's an honor to be able to come here and help out," said Chief Hospital Corpsman (sel) Mark Coulombe, one of the NHB volunteers undertaking the community relations project. Just being here is symbolic and is a mark of respect to our roots.

The CPO-selectees and their chief petty officer sponsors handled ground-keeping chores and replaced railroad ties that served as steps to the Navy Plot. They chipped, sanded and painted worn-ports on the replica of the Tomb of the Unknown Soldier and completely spruced-up Nibbes grave marker and site.

According to Don Hock, City of Bremerton Parks and Recreation Department cemetery grounds keeper and manager, the original cemetery opened in 1898 and expanded in 1902. There are veterans from every branch of the service from as far back as the Civil War and Spanish-American War, both World Wars, the Korean War and Vietnam War. "We don't have any yet from Iraq or Afghanistan, knock on wood," Hock said. "There is a lot of history here,"

said Chief Gunners Mate (sel) Kevin Wyant, engaged in cleaning up the Navy plot. "Being here lets us give back to our community."

The Navy plot is the largest in the cemetery and is the final resting place for 61 crew members killed in action on USS Saratoga, CV-3, Feb. 21, 1945, off Iwo Jima. The Saratoga was brought back to the Bremerton shipyard for necessary repairs, related Hock. There were remains on board that couldn't be identified after the ship was bombed by attacking Japanese airplanes, so the best way to honor them all was with a group memorial.

Sailors from the Portland, Ore., Navy Operational Support Center (NOSC) received some assistance during the holiday season courtesy of the local Navy League of the United States Blueback Submarine Council. hearty holiday meal." Mason and Steacy are hoping to continue this holiday tradition of helping service members throughout the coming year, and next Christmas as well.

■ **Elections** – Mark Lowe and Louis Mejia were elected to the 2009 Board of Directors at the November meeting of the Council.

■ **Committee Chair Requested** – USS Alabama completes her overhaul and conversion from Trident I to Trident II in May. The ship is planning a "Return to Service Ceremony" in May or June. Following the precedent of the SSGN's, Gary Gunderson has been asked to look into our Council assisting the USS Alabama with the Return to Service Ceremony.

■ **Operation Holiday Spirit** – Over \$4,100 donated from business, affiliates members and our Council. Gift Cards and Holiday items to go to Chaplin Brown right after the December luncheon.

■ **Lone Sailor** – Donations total over \$243,000. Additional fundraising still needed for the Dedication Ceremony and Interpretive Wall.

Veterans No Longer Breaking the Law

For Veterans that have been saluting during the playing the national anthem can now rest at ease. The Defense Authorization Act of 2009, signed into law by President Bush on October 19th, amends Section 301(b)(1) of title 36, United States Code, allowing veterans and active duty personnel out of uniform to salute the flag during the playing of the national anthem. The original law, National Defense Authorization Act of 2008, forgot to include the national anthem when it authorized hand-salutes for veterans and out-of-uniform military personnel during the raising, lowering or passing of the flag. So now we can do both.

SEC. 1081. MILITARY SALUTE FOR THE FLAG DURING THE NATIONAL ANTHEM BY MEMBERS OF THE ARMED FORCES NOT IN UNIFORM AND BY VETERANS.

Section 301(b)(1) of title 36, United States Code, is amended by striking subparagraphs (A) through (C) and inserting the following new subparagraphs:

(A) Individuals in uniform should give the military salute at the first note of the anthem and maintain that position until the last note;

(B) Members of the Armed Forces and veterans who are present but not in uniform may render the military salute in the manner provided for individuals in uniform; and

(C) All other persons present should face the flag and stand at attention with their right hand over the heart, and men not in uniform, if applicable, should remove their headdress with their right hand and hold it at the left shoulder, the hand being over the heart.

Comings & Goings

In a recent change of command ceremony while underway in the Eastern Pacific Ocean on board USS Rodney M. Davis (FFG60) **Cmdr. David Stuffle relieved Cmdr. James Minta** as commanding officer of the Everett-based frigate.

The ceremony marked the culmination of Minta's first at-sea command during which he led Davis in a highly successful unit level training period followed by the beginning of a counter-narcotics terrorism deployment. Minta will next report to Headquarters, European Command in Stuttgart, Germany.

Davis is Stuffle's second at-sea command. He previously commanded USS Gladiator (MCM 11). He reports from Industrial College of the Armed Forces in Washington DC.

Davis is deployed under the operational control of U.S. Naval Forces Southern Command (NAVSO) as part of the Joint/Inter-Agency Task Force conducting counter-narcotics terrorism operations in the Eastern Pacific.

Fleet Readiness Center Northwest was recently commissioned as one of the Navy's newest activities. Witnessed by more than 500 people, Commander, Electronic Attack Wing Pacific, **Capt. Brad Russell** pinned the coveted Command Ashore insignia on the unit's first commanding officer, **Cmdr. James M. Parish**. The commissioning transitioned what used to be known as the Aircraft Intermediate Maintenance Department, or AIMD, was officially established as FRC NW. The command pennant was presented immediately following the pinning.

Remembrance Ceremony Held at Keyport

A few of our Council Members attended the remembrance ceremony that Naval Base Kitsap, Keyport held for the 1941 attack on Pearl Harbor at the Naval Undersea Warfare Museum Dec. 7. The ceremony was in commemoration of the 67th anniversary of the Day that will live in Infamy, by what was then Imperial Japan, and was the 15th such ceremony held at Keyport.

Capt. Stephen Iwanowicz, commander, Naval Undersea Warfare Center and master of ceremonies, spoke to a maximum occupancy crowd of survivors, veterans, active duty personnel and their families and friends about what Pearl Harbor meant for the future of the country.

“Let us never forget the sacrifices that were made on that day and so many others for the continuation of the principles that guide this great country,” said Iwanowicz. “Their strength, drive, and devotion to the United States and its people brought us all through those troubled times and achieved supreme victory for our combined cause.”

At the end of the ceremony, the floor was opened to the audience, where survivors of the attack were invited to give their own, first-hand accounts. Tom Bird, a former crew member of USS Tennessee (BB 43), joked that he and his crewmates were some of the only Sailors awake when the attack first started. “I guess we had a pretty good crew,” said Bird, as the audience and fellow survivors laughed. Bird struck a serious note as well, noting how he felt like more should have been done to prevent the attack, and how unprepared everyone was. “I won’t get into the politics of it all, but I know a lot could have been done differently. The important thing is we learned from our mistakes and became stronger than ever before, he said. That type of attack would be impossible today.

South Kitsap High School Navy Junior Reserve Officers Training Corps

The Navy program was established by act of Congress in 1964 and pushed by GEN Colin Powell then Chairman of the Joint Chiefs as a vehicle to assist in the growth of citizenship and leadership among our youth. The Army had a JROTC in place well before the other services but with the impetus given by the Chairman and Congress the Navy Junior Reserve Officers training Corps (NJROTC) was established.

South Kitsap H. S. NJROTC was established December of 1996 and has been very active in the school and community ever since. The objective of the program is to instill a sense of accountability and responsibility in our young men and women, giving them a better understanding of their government and how it operates while teaching them that they must give back to their community if they want it to flourish and grow. There is training, both hands on and scholastic, in the art of good leadership.

Our unit is set up like and active duty naval unit with a cadet Commanding Officer, Executive Officer, Operations, Administration, Supply etc., and Enlisted cadet Seaman Recruit through cadet Master Chief Petty Officer. The cadets work their way up the chain of command through demonstrated effort, initiative and individual performance. Selection to Chief Petty Officer and above is done through cadet input and over seen by SgtMaj Brook USMC (Ret) and CAPT Tetrick USN (Ret). Promotion to the top four positions is by a cadet Selection Board made up of the top four first year cadets, the cadet CO, XO, OPSO, CMC. SgtMaj Brooks or CAPT Tetrick acts as a tie breaker.

The South Kitsap Wolf Company has been selected as a distinguished unit (Top 30% in the Nation) for the last eight years, a tribute to the outstanding young

men and women who have passed through our unit on their way to becoming strong, responsible and trust worthy citizens of this great Country.

It has and continues to be SgtMaj Brooks and my pleasure to help guide and direct these terrific students. I look forward to the experience each and everyday.
