Captain Mark Olson – Speaker for January 11 Luncheon and Installation

Captain Olson has been such a strong supporter of the Bremerton-Olympic Peninsula Council since he assumed command of Naval Base Kitsap in June 2008. He has made us most welcome on his base and has been a great supporter of our many events. He has also reached out to the members of the community and the business and civic organizations to keep them informed about the great naval presence in our area and to establish a strong working relationship with them.

Captain Olson does this in addition to being the commanding officer of the third largest installation in the United States Navy, covering nearly 11,000 acres in three states and home to nearly 31,000 people.

While he says that his military career has been easy compared to growing up in Minnesota with three sisters, his accomplishments tell another story. He graduated with distinction from the United States Naval Academy in 1983, receiving a BS in Oceanography. Later, he received a Master of Arts Degree from the Univer-

sity of Memphis. He studied as a Senior Executive Fellow at the Harvard Kennedy School of Government and earned a Masters Degree in Engineering Management from Old Dominion University.

He has served all over the world on land and under the sea with so many different responsibilities. His bio mentions Groton, CT, Naples, Italy, Western Pacific, Arabian Gulf, Mare Island Shipyard, Bangor, WA in 1994, 1996 and 2001, Millington, TN, Pearl Harbor, and Omaha, NE before returning here. He served on the USS Tullibee, USS Helena, and USS Henry M. Jackson (Gold) and he supervised the relocation of the command detachments and the USS Parche from Mare Island to here.

Captain Olson has been awarded the Defense Superior Service Medal, Legion of Merit (2 awards), Meritorious Service Medal (2 awards), Navy Commendation Medal (5 awards), Navy Achievement Medal (3 awards) and various campaign and unit awards.

Truly, Captain Olson is a very remarkable man and a true friend to Navy League. Of course, one of his outstanding accomplishments was to marry Linda.

The ship will be homeported there for a year while undergoing refitting, upgrades and repairs at adjacent Puget Sound Naval Shipyard and Intermediate Maintenance Facility.

It will then relocate to Everett replacing the USS Lincoln.

We had the special privilege of meeting as a group with Commanding Officer, Captain Paul Monger, immediately following his address to the media. We then received a short tour of the ship by PAO Officer LCDR Steve Ruth. We have been assured of a full tour when the ship comes out of the yard next year.

Thanks also to Tom Danaher, PAO Naval Base Kitsap. A visual highlight of the event was a large rainbow, which stretched across the bow of the ship in the dark sky. Captain Monger has promised to join us at council functions and we look forward to seeing him again.
