Council Nominating Committee Established

Strategic Weapons Facility Pacific Update

Captain Chuck LaSota, Commanding Officer of Strategic Weapons Facility Pacific, provided our membership with an update on his command at the June luncheon. Captain LaSota was accompanied by Lt. Col. Jim Dillon, Commanding Officer, Marine Corps Security Force Company; Master Chief Perkins, Command Master Chief; and Public Affairs Officer Denise Barnes. He started by thanking the membership for supporting the Sailors and Marines of his command.

Captain LaSota described the priorities at SWFPAC, which are Safety, Security, Quality, Schedule, and Productivity/Efficiency. He explained their importance to meeting the command mission, which is to provide missiles and weapons systems support to the fleet (SSBNs, SSGNs, and SSNs). SWFPAC has a workforce of 1561 including government workers and contractors working alongside Sailors and Marines. The SWFPAC security force comprises about 50% of the workforce. Training and qualifications include indoctrination of new people, production schools, formal qualifications, and annual re-certifications. SWFPAC capabilities include Missile Assembly and Testing, a Calibration facility that supports all ships in the region, and support of START treaty inspections.

Captain LaSota described the challenges of handling Trident II D-5 missiles now versus the Trident I C-4 missiles the command handled just a few years ago. The Trident II D-5 missile is almost twice as heavy as the Trident I C-4 requiring larger

handling equipment and slower operations. He emphasized that preparations to load a missile take almost a month, even though the loading evolution is completed in a single day. Captain LaSota discussed the recent successful FCET-35 conducted by USS Alaska, which proved the accuracy and reliability of the Trident Weapon System.

SWFPAC won the Strategic Systems Program Raborn Award for the second year in a row this year, the third time that the command has won the award, for best facility within the SSP claimancy.

Coast Guard Receives Upgraded Helicopter



The Coast Guard recently delivered the first of three re-engined HH-65 Dolphin helicopters to Coast Guard Air Station Port Angeles as part of the Deepwater Program.

Twin-engine HH-65 helicopters are particularly well-suited for search and rescue, fisheries patrols, maritime security, border patrol, monitoring illegal immigration, and drug interdiction.

The Deepwater Program is the largest modernization and recapitalization program in the history of the Coast Guard. The remaining two helicopters are scheduled to be delivered by mid July to ensure the unit has a full complement of upgraded aircraft.
