Captain Tanaka Addresses Naval Base Kitsap Growth

For the September luncheon, we had a return engagement by Captain Reid Tanaka, Commanding Officer, Naval Base Kitsap (NBK). The topic for this presentation was NBK growth and challenges associated with that growth.

Captain Tanaka spent much of his time talking about the 8-2-4 growth plan and the challenges associated with it. 8-2-4 stands for 8 Trident Submarines; 2 SSGN Submarines; and 4 SSN Submarines. The biggest challenge is the mixed mission and the real estate required for this many submarines—life was simpler when Bangor only supported 6 Trident Submarines and one special mission submarine.

Captain Tanaka went on to address the challenges brought on by this growth and what he is doing to manage it. The challenges are significant and include housing additional personnel (including the newly assigned Coast Guard personnel), personnel parking, pier space for the addition submarines, weapons handling concerns/explosive arc requirements, vessel and transiting vessel security, and mission growth.


One of the most obvious mission growth areas is the addition of US Coast Guard personnel who will be manning the Transit Protection System (TPS)—this is a new mission area and has a Joint Regional Flag Board established for coordination. Bremerton will probably see operational submarines stationed there to alleviate the pier congestion at Bangor.

Captain Tanaka concluded his presentation by addressing the Navy's Individual Augmentee Program. The purpose of this program is for the Navy to send officer and enlisted personnel to support the land forces in Iraq and Afghanistan. The challenge is that the Navy is organized to handle the deployment of entire organizations, not just ones and twos. When the Navy first started this program, they sent 4000 folks, they are currently supporting 8000, and expect to go to 10,000 in the near future. Most Augmentees are deployed for 6-12 months in country plus training stateside. The Captain asked if there was anyone who would like to volunteer to help him support the deploying member's family. If you are interested, contact Larry Salter and he will provide the list to Captain Tanaka.

The presentation concluded with a question and answer period and the traditional "mugging" by President Larry Salter.


